Lisa Parker's Puppies (LPP) is a local non-profit 501(c)(3) organization. Lisa Parker is a Durango, CO native who has been rescuing dogs in remote areas of the Four Corners for more than ten years. Lisa, with the support of her husband Eric, officially launched LPP in the spring of 2014 after taking in a litter of 6 day old bottle-feeding puppies. Since that day, LPP has developed a diverse team of foster homes and volunteers who, along with our community partners, create a network of opportunity for dogs in need. LPP also works closely with local and regional humane societies, Dogster and similar organizations to rescue, transport, care for and re-home dogs and puppies in need in the surrounding areas. During 2018, LPP took in 116 dogs of which 112 of them have been adopted (96.6% live release rate)
